2. User rights

PENTHOUSE ORHIDEEA grants the user limited access, in their personal interest, to this site and does not grant them the right to download or modify the site in whole or in part, to reproduce the site in whole or in part, to copy, to sell / resell or operate the site in any other manner, without the written consent of PENTHOUSE ORHIDEEA.

3. Security of personal data

Your personal data may be transmitted to the law enforcement authorities for the purpose of verification commercial transactions or other law enforcement authorities for any justified check in the basis of the law.

This site uses security measures against the loss, alteration or misuse of information that is under our control.

PENTHOUSE ORHIDEEA undertakes to respect your rights conferred by Law 677/2001, and at your request sent to PENTHOUSE ORHIDEEA undertakes to: rectify, update, block, delete or transform into anonymous data, for free, data whose processing is not according to the provisions of Law no. 677/2001 regarding the protection of persons with regard to processing personal data and the free movement of such data; to stop data processing your personal.
